Dear Parent/Guardian,

We hope that you and your families are all doing well. Here at Cristo Rey, the health and safety of our students is a priority, and with that in mind, we would like to tell you about an exciting new program we will be adding to our school community next school year. We have partnered with a Federally Qualified Health Center (FQHC) called Greater Philadelphia Health Action (GPHA) to open a health clinic in our school building to provide services to our students starting in the 2020-2021 school year.

This health clinic will allow Cristo Rey students to have access to all the same medical services they would typically receive at their Primary Care Physician's office, including annual physicals, sports physicals, chronic disease management, immunizations, laboratory services, and dental services. You will not need to change your Primary Care Physician in order to have access to these services. Also, there will be no out of pocket costs for our families.

In order for your child/children to be seen by the clinic, we will need to obtain consent from a parent or guardian. Following this correspondence, you will receive an email from Greater Philadelphia Health Action asking you to complete a HIPAA Student Registration Packet form. Please complete this form to give your consent for your child to be seen by the medical professional in the health clinic starting in the fall. For those who are not able to do this online, we will send out paper consent forms once we are back in our building.

- Obtain and complete GPHA Consent form electronically or via hard copy.
